**Metropolitan Police Department Applies for CALEA® Re-Accreditation;  
Accreditation Assessment Team Invites Public Comments**

The Metropolitan Police Department, City of St. Louis (“the department”) will host a team of assessors from the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA®) on December 13, 2010. The on-site assessment team will examine all aspects of the department’s policies, procedures, management, operations and support services. Public comment is invited by the on-site assessment team.

CALEA® was established in 1979 to assist law enforcement agencies in establishing and maintaining high standards of excellence. Though voluntary, accreditation is a highly-regarded acknowledgement of public safety professional excellence and ensures that law enforcement agencies meet state-of-the-art standards. The department first sought accreditation in the mid 2000s and after participating in a multi-year process, a full, three-year accreditation was awarded in 2007. The department is now seeking re-accreditation for a second three-year period. Accreditation requires the department to comply with 464 CALEA® standards and undergo review by an on-site assessment team, comprised of public safety practitioners from out-of-state agencies. The assessors will review written material, interview individuals and visit offices and other locations where compliance can be witnessed. Following the on-site assessment, the assessment team will report their findings to the full Commission which will then determine if the department will be granted re-accreditation.

As part of the on-site assessment, members of the community and department employees are invited to offer public comments to the on-site assessment team by phone or in person. Those offering comment must limit their statements to 10 minutes and must address the agency’s ability to comply with CALEA® standards. The CALEA® standards can be reviewed at police headquarters, 1200 Clark Avenue.

**Phone comments will be accepted by the on-site assessment team on Monday, December 13, 2010 from 2 p.m. until 4 p.m. Those wishing to offer comment may call (314) 444-1275. In-person comments will be accepted during a public session later the same evening, Monday, December 13, 2010, beginning at 7 p.m. The session will take place at police headquarters, 1200 Clark Avenue, on the sixth floor in the large board room.**

Persons who are unable to make comments by phone or in person may also offer written comments about the department's ability to meet the standards.
