



Message from the Chief of Police



While 2011 certainly brought its challenges, the Metropolitan Police Department, City of St. Louis provided outstanding police service to citizens and visitors to the city of St. Louis. The men and women of this department have worked diligently to protect those who live, work and visit our city. As a result of the hard work and dedication of our officers, the city of St. Louis once again had record low crime numbers in 2011. The statistics show that overall crime as well as the most serious violent crimes experienced decreases for the year.

In 2011 there were 31,811 reported Part I Crimes which is comprised of Homicides, Forcible Rapes, Robberies, Aggravated Assaults, Burglaries, Larcenies/Thefts, Vehicle Thefts and Arsons. This represents a 5.9 percent decrease from 2010 when there were 33,782 reported Part I Crimes.

The department reported 113 Homicides in 2011, a 21.5 percent decrease from the 144 reported in 2010.

Looking at the numbers for 2011 there are things that tell us we are moving in the right direction. We had another positive year, but there is still much work to be done. We saw a significant drop in homicides but ultimately, even one homicide is more than we want to see. We will continue to work with others in the community and our law enforcement partners to further reduce crime in the city of St. Louis.

A statistical overview of crimes occurring in the city of St. Louis is included on the subsequent pages of this report for your review.

Lt. Col. Adkins serves as Commander of the Bureau of Community Policing, which is the largest bureau within the department. He oversees a budget of approximately \$35 million and supervises more than 1,000 commissioned officers and civilian employees. The Bureau of Community Policing includes the nine Police Districts, the District Detectives and the Housing Unit.

Paul M. Nocchiero

Lt. Col. Nocchiero serves as Commander of the Bureau of Auxiliary Services. He oversees a budget of approximately \$22 million and supervises 350 employees assigned to the bureau, which includes Communications, the Crime Laboratory, Property Custody, Records Division and Telephone Reporting. He is also responsible for overseeing all police facilities and the maintenance of both the police radio system and the department's fleet.

Lt. Col. Filla serves as Commander of the Bureau of Investigation & Support. She oversees Crimes Against Persons and Property, which includes Homicide, Sex Crimes, Child Abuse, Domestic Abuse, Bomb & Arson, Fraud and Cyber Crimes and those police officers assigned to the Circuit Attorney's Office as investigators. She also oversees Tactical Enforcement including Narcotics, the Violent Offenders Unit, Anti-Crime Unit, Warrant & Fugitive Unit and Prisoner Processing. Support Operations, which consists of Traffic Safety, Mounted Patrol, Mobile Reserve, Canine, Emergency Management, Aviation and Public Transportation, also fall within Col. Filla's bureau.

Lt. Col. Reagan serves as Chief of Staff in the Office of the Chief of Police, where he serves as the top advisor to the Chief of Police. He also oversees Planning & Research, Commission on Accreditation for Law Enforcement Agencies (CALEA), Information Technology, Crime Analysis, Intelligence, Public Information and Operational Planning.




Lieutenant Colonel

Metropolitan Police Department – City of St. Louis Organizational Chart*










Directed Incidents - By Division


Directed Incidents - By Month

MOURNING THE LOSS



Police Officer Daryl A. Hall 1977 – 2011



On Sunday, April 24, 2011, Police Officer Daryl Hall died as a result of gunshot injuries sustained while involved in an off-duty incident. He was 34 years old.

At 2:38 a.m., police responded to an officer-involved shooting at 800 S. 4th Street, the parking lot of the Black Label Nightclub, where Officer Hall was a patron. An altercation between other patrons inside the nightclub erupted. Those patrons were escorted from the nightclub. Witnesses stated after the altercation was moved outside onto the parking lot, the suspect retrieved a handgun and began firing shots. When Officer Hall heard the gunshots, while still inside the nightclub, he went outside to investigate. Witnesses on the parking lot said, Officer Hall observed the suspect firing a handgun. At which time, Officer Hall announced he was a police officer and ordered the suspect to drop his weapon. The suspect refused and gunfire was exchanged between Officer Hall, the suspect and a person providing security for the nightclub. Officer Hall suffered two gunshot wounds, one to his neck and one to his bicep. Officer Hall was transported to St. Louis University Hospital where he was pronounced dead at 3:16 a.m.

The suspect, a 30-year old male, was shot multiple times. He was pronounced dead at the scene. His weapon was recovered at the scene. The 30-year old male, who was providing security for the nightclub, was questioned by police and released. He was not injured. His weapon was also recovered at the scene.

Officer Hall joined the department in November 2005 as a Civilian Recruit in Training. On July 13, 2006, he graduated from the St. Louis Police Academy as a commissioned St. Louis Police Officer. During his career with the department Officer Hall served in the Sixth District as a patrolman. At the time of his death he was a patrolman assigned to the Housing Authority Unit. He is survived by his mother, stepfather, brother and a host of other family members and friends in addition to his police family.
