#### **MEETING MINUTES**

#### Wednesday, October 8, 2025 at 9 am

The meeting of the St. Louis Board of Police Commissioners ("Board") was called to order by Board Attorney, Chris Graville, at 9:08 am on Wednesday, October 8, 2025, at the St. Louis Metropolitan Police Headquarters, 1915 Olive Street, St. Louis, Missouri. Notice was timely given, and members of the public were present.

Mr. Graville performed the roll call confirming the following individuals were present, satisfying the quorum requirements: Commissioner Brad Arteaga, Commissioner Don Brown, Commissioner Sonya Jenkins-Gray, Commissioner Edward McVey, Commissioner Chris Saracino, and Mayor Cara Spencer.

Mr. Graville then led the Pledge of Allegiance.

Commissioner Arteaga moved to approve the minutes of the August 6, 2025 Board meeting as written. A roll call vote was held.

The motion to approve the August 6, 2025 minutes passed with a vote of 5-0.

#### Elections of President, Vice President, Secretary, and Treasurer of the Board

Under New Business, Mr. Graville explained that due to the Governor temporarily pulling the commissions of the Board members in September, the Board would need to re-elect members to the positions of President, Vice President, Secretary, and Treasurer of the Board. Commissioner Saracino moved to nominate a slate of candidates for the open positions, with Commissioner Saracino as President, Commissioner Jenkins-Gray as Vice President, Commissioner Arteaga as Secretary, and Commissioner McVey as Treasurer. No alternative slate of candidates was proposed. A roll call vote was held on the motion to nominate a slate of candidates.

Commissioner Saracino – Aye Commissioner Jenkins-Gray – Aye Commissioner Arteaga – Aye Commissioner McVey – Aye Mayor Spencer – Aye The motion to appoint Commissioner Saracino as President, Commissioner Jenkins-Gray as Vice President, Commissioner Arteaga as Secretary, and Commissioner McVey as Treasurer passed with a vote of 5-0.

# Labor Management, Litigation, and Budget, Finance and Audit Committee Appointments

Commissioner Saracino moved to nominate a slate of candidates to the Board's Committees, nominating Commissioner Brown to the Labor Management Committee, Commissioner Arteaga to the Litigation Committee, and Commissioner McVey to the Budget, Finance and Audit Committee. After debate and discussion, a roll call vote was held on the motion to nominate the slate of Committee candidates.

The motion to appoint Commissioner Brown to the Labor Management Committee, Commissioner Arteaga to the Litigation Committee, and Commissioner McVey to the Budget, Finance and Audit Committee passed with a vote of 5-0.

# **Committee Reports**

Commissioner McVey gave a report on behalf of the Budget, Finance, and Audit Committee. Commissioner McVey moved to approve the Resolution Requesting Transfer of Certain Human Resources Positions from the City of Saint Louis to the Department. After debate and discussion regarding the positions to be transferred, the responsibilities of those positions, and the budgetary implications of the transfers, a roll call vote was held on the motion.

Resolution No. 2025-11 passed with a vote of 4-0, with Mayor Spencer abstaining.

Commissioner McVey then moved to approve the Resolution Authorizing the Department to be Treated as a County Office for Purposes of Oracle System. A roll call vote was held on the motion.

Commissioner McVey moved to approve the Resolution to Adopt a Travel Policy. After debate and discussion, including a request for the inclusion of a fiscal note related to any resolutions impacting budgetary items, a roll call vote was held on the motion.
